Sub.: Request for Extension of Provisional Affiliation Beyond 31/03/ 2019 – reg.

Sir/Madam,

This has reference to your online application bearing registration no **EX-01315-1920** on the above subject and the subsequent compliance report dated 28/08/2019.

In this regard, the following deficiencies / requirements have been observed for compliance. The School is required to submit the compliance of the deficiencies / requirements.

1. The school is required to submit the copy of Land Certificate as per appendix VI of affiliation Bye-Laws of the Board duly certified by Competent Authority i.e. Sub Registrar/ Tehsildar/ District Magistrate etc. to the board as per the boards' norms.
2. The school is hereby informed that Rule no. 3.1.5 of affiliation Bye-laws of the Board has stated that **"The land mentioned in 3.1.1 above should be surrounded on all sides by a pucca boundary wall of sufficient and adequate height."** Therefore, the school is directed to run in 1.18 area of land & construct the playfield area in same boundary wall in view of safety of students and submit the CD of aerial view of the entire campus with boundary on all four sides in continuity with building and Playground.
3. The school has submitted Building Safety Certificate dated 24/09/2019 issued by Pvt Structure Engineer instead of concerned/Competent Authority, i.e., PWD or Nagar Nigam Department of the State Government . Hence the school is required to submit revised copy of said certificate duly certificate by aforesaid department as per Board norms.

Further keeping in view, the academic interest of the students, I am directed to convey approval of the competent authority for provisional extension of affiliation upto **31.03.2021** alongwith permission for registration of bonafide candidates of class IX / XI and submission of list of existing candidates of the School for class X and XII for current session.

However regularization of affiliation from **01.04.2019** for a period of 05 years will be subject to the specific compliance on the discrepancies communicated by the School at the earliest not later than 60 days of issue of this letter failing which a penalty of Rs.20,000/- per month will be levied on the school and the process of withdrawal of affiliation may also be initiated.
